MEMORANDUM

To: Plumbers License Requests

Re: Insurance / Bond Requirements

Bond

You will need to enter into a bond through a corporate surety company in the penal amount of \$1,000.00 (one thousand dollars) conditioned upon the payment of all sums for which he may become liable as a result of violation of the terms of this ordinance²¹ in the performance of his work as a Master Plumber. Such bonds shall be in a form prescribed by the Borough of Chambersburg and shall be furnished to the Borough. (see attached)

Insurance

You will need to carry standard policies of public liability and property damage insurance in the following amounts:

General Public Liability Insurance	\$100,000/\$300,000
General Property Damage Insurance	\$25,000
Automobile Public Liability Insurance	\$100,000/\$300,000
Automobile Property Damage Insurance	\$25,000
Workmen's Compensation	In accordance with law

Certificates of each such policy shall be furnished to the Borough indicating the amount and type of insurance carried and stating that such coverage may not be cancelled without a (10) ten days advance notice to the Borough.

The Borough of Chambersburg must have a copy of your Bond/Insurance before you will receive the Special License.

PLUMBER'S BOND

KNOW ALL MEN BY THESE PRESENTS, That we _____
_____, as Principal, and

_____ as Surety, are jointly and severally held and firmly bound unto the Mayor and Town Council of the Borough of Chambersburg, a municipal corporation in Franklin County, Pennsylvania, herein called Borough, in the sum of one thousand (\$1,000.00) dollars, lawful money of the United States, to be paid to the said Borough, its certain attorneys, successors or assigns, to which payment, well and truly to be made and done, we and each of us do hereby bind ourselves, our heirs, executors, administrators, successors or assigns, and every of them.

SEALED with our hands and seals and dated the _____ day of _____, 20____.

NOW THE CONDITION OF THE ABOVE OBLIGATION IS SUCH, That if the above bounded Principal and Surety, their heirs, executors, administrators, successors or assigns, or any of them, shall and do pay all sums of money for which the said _____, Principal, may become liable as a result of the violation in the performance of his work as a Master Plumber under the terms of an Ordinance of the Borough passed by the Town Council on the 30th day of November, 1964, and approved by the Mayor on the 30th day of November, 1964, then the above obligation to be void, or else to be and remain in full force and virtue.

This bond shall remain in full force and effect as to the Principal so long as he is the holder of an plumber's license issued by the Borough, and as to the Surety for one year from the date hereof and thereafter until terminated by written notice to the Borough at least then (10) days prior to the end of the year or to the date of termination, whichever is later.
