TYPE OF WORK:

Description of Responsibility:

Responsible for the basic repair, maintenance and operation of all process equipment at the Wastewater Treatment Plant as well as the equipment at the sewage pumping stations. The primary role of this position is focused on plant maintenance versus plant operations. Performs a broad range of maintenance and repair work and performs other related work as required. Operates the Wastewater Treatment Plant on assigned shifts. Receives direction from the Chief of Maintenance and Chief of Operations and receives general supervision from the Plant Supervisor.

Duties:

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

Knowledge of:

- Borough policies, rules, procedures and regulations.
- Methods, materials, tools and equipment used in the installation, dismantling, repair, and overhaul of mechanical and electrical equipment for wastewater treatment.
- Pump station equipment inspection, maintenance and repair.
- Principles and practices of wastewater treatment plant and pumping facility operations.
- Electrical and pneumatic control systems.
- Construction methods and procedures.
- Work safety programs including confined space entry procedures.
- The maintenance and repair of controls and control devices.
- Basic computer skills.

Ability to:

- Perform the preventive maintenance and equipment repair functions of the Borough's Wastewater Treatment Plant and pump stations.
- Implement work safety methods.
- Perform a wide variety of inspection, maintenance and repair work on the Borough's equipment and machinery.
- Read and interpret gauges, recording devices and other monitoring equipment reflecting plant and facility operations.
- Identify when unusual operating problems occur.
- Understand and carry out oral and written instructions.
- Read and write at the level required for successful job performance.

- Work unusual shifts, weekends, evenings and holidays when required.
- Maintain good public relations with people contacted during work assignments.
- Establish and maintain cooperative working relationship.
- Learn new or different maintenance techniques and methods to better maintain WWTP equipment.

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee is frequently required to stand; sit; use hands to finger, handle, or feel; reach with hands and arms; climb or balance; stoop, kneel, crouch, or crawl; and talk or hear. The employee must frequently lift and/or move up to 25 pounds and occasionally lift and/or move up to 50 pounds. Specific vision abilities required by this job include close vision, distance vision, depth perception, and ability to adjust focus.

Additionally, the employee is frequently exposed to outside weather conditions. The employee is occasionally exposed to high, precarious places; fumes or airborne particles; toxic or caustic chemicals; extreme cold; extreme heat; and risk of electrical shock. Employees in this classification may perform duties that involve a potential risk of exposure to blood borne pathogens. The noise level in the work environment is usually loud.

MINIMUM REQUIREMENTS:

- Must have a basic knowledge of the methods, materials, tools and equipment used in the installation, dismantling, repair and overhaul of mechanical, electrical, hydraulic, and control equipment.
- Complete at least one wastewater treatment course annually which is acceptable to the State Board for Certification of Water and Wastewater Systems Operators. This will show continued progression toward the experience required for certification to operate the Chambersburg Wastewater Treatment Plant which is a Class A, Type 1 at the current time.
- High school diploma or equivalent.
- One year of work experience in electrical (including 3-phase) and mechanical repair and maintenance.
- Completion of trade school or advanced training in industrial equipment and repair is desirable.
- Must have and maintain a valid Commonwealth of Pennsylvania motor vehicle operator's license, 3 years clean driving history, and be insurable in the independent opinion of the Borough's motor vehicle insurance underwriter, in order to be eligible for this position. Must have or obtain a Pennsylvania Motor Vehicle Operations License Class B with Air Brakes and Commercial Endorsement N tank prior to the end of the probationary period.
- Must have basic computer skills with a working knowledge of Supervisory Control and Data Acquisition (SCADA) systems.
- Must have thorough knowledge of safe work practices and regulations including electrical safety.
- Must be eligible for on call and standby duty.
